- **Observations**: court marital cases and Hizba marital conflict resolution case observations were conducted to assess the actual success and challenges of marital relationship
- **Data Analysis:** Qualitative data from interviews and observations were subjected to thematic analysis to identify recurring patterns, themes, and narratives related to marital relationship among Muslim couples in Ringim Local Government Area.

# FINDINGS

**1. Lack of Emotional Intimacy:** The findings revealed that there is a lack of emotional intimacy among the couples which have led to misunderstanding, miscommunication, and a lack of harmony. These have resulted to frequent conflicts, resentment, and a weakening of the marital bond.

**2. Economic Pressure:** The findings also reveal that there is an economic pressure among the Muslim Couple in the area which have also created tension and conflict between spouses. Disagreements about spending, saving, or managing finance led to arguments and create a sense of division within the marriage.

**3. Communication Gap:** The study identified absence and deterioration of communication gap which resulted to increased misunderstandings, emotional distance, weakened trust, reduced marital satisfaction and undermining the stability of a marriage in general.

- Unnecessary stress over material wealth and prevents them from falling into the trap of excessive consumerism or debt.
- **Regular and Open Communication:** Couples should make it a habit to regularly set aside time for open and honest conversations. This could be a weekly or daily check-in where both partners discuss their feelings, concerns, and aspirations. Listening is as important as speaking. Active listening involves giving full attention to your spouse, acknowledging their feelings, and refraining from interrupting. This helps in understanding each other better and reducing misunderstandings.

### DISCUSSION

The assessment of marital relationship among Muslim couple in Ringim Logal Government Area, presents both challenges and solutions. While the current situation of marital relationship is unjust, there is a great need to address the issue in order to have a harmonious family relationship. The challenge identified, predominantly related to economic pressure, is significant but not overwhelming.
